Each partner reports their share of the partnership's income or loss on their personal tax return. Partners are not employees and shouldn't be issued a Form W-2. The partnership must furnish copies of Schedule K-1 (Form 1065) to the partner.

Though a partnership doesn't pay taxes on its profits, it does declare its operating losses and profits to the IRS in Form 1065. The partnership must also send Form K-1 to owners that states profits/losses allocated to each partner (the K-1 is reported on line 17 of your personal tax return 1040).

Partnership Taxes - FindLaw

Step 1: Preparation of Partner's Schedule K-1 . Along with the partnership information return on Form 1065, the tax preparer also prepares a Schedule K-1 for each partner, which breaks down the partnership income and share of that income for that partner, along with other information. The Schedule K-1 is filed with the partner's personal income tax return, and the amount of loss or income is included along with the partner's other income.

Form 1065 is used to report the income of every domestic partnership and every foreign partnership doing business in the U.S. or getting income from U.S. sources. Partnerships file an information return to report their income, gains, losses, deductions, credits, etc. A partnership does not pay tax on its income but "passes through" any profits or losses to its partners.

FORM 'I' - Registration Department

Fill out Forms First, you'll need a Form 1065. This is the form that allows the partnership LLC as an entity to report its income. Then the individual partners will pay income taxes based on their individual tax rates, rather than paying as an entity.
